

## WNAX/TRI-STATE OLD IRON ASSOCIATION'S ANTIQUÉ TRACTOR RIDE SAFETY PLEDGE

I, \_\_\_\_\_, hereby pledge to hold safety as the highest priority on the WNAX/Tri-State Old Iron Association Tractor Ride. The safety of my fellow riders, and the public traveling on the route, is of the utmost importance. I pledge to obey the following rules:

1. All drivers must be at least 16 years of age with a valid driver's license.
2. All participants must follow all traffic laws.
3. The consumption of alcohol while operating a tractor in our ride is prohibited.
4. All tractors must display a SMV sign to participate in the ride.
5. No passengers allowed. (One seat-One driver) If your tractor is equipped with a proper second seat, someone who is at least 16 years of age can ride with you.
6. Tractors are not to pull campers or trailers, but small carts are permitted.
7. All tractors **must** travel a minimum of 12 MPH and follow the designated route.
8. All participants must depart during their assigned group's designated time and must stay with their assigned group.
9. All drivers must drive on the shoulder of the highway whenever possible and passing is prohibited.
10. A distance of 2-3 semi-trailer lengths should be maintained between each tractor to allow cars, trucks, motorcycles, etc., to pass safely.
11. All participants must abide by the decisions of WNAX/Tri-State Old Iron Association based on the national weather service in the event of inclement weather.
12. If you fail to follow these rules, you may not be invited back for next year's ride.

**Please help us make this a fun and safe ride!**

I understand that breaking these rules will result in the denial of future applications. Repetitive violators will be asked to leave the ride, per the ride management team.
